would like to thank you for
having me back as CEO
of Southwest Healthcare
Services. The community
of Bowman and Bowman
County feels like home
and I have always felt this

community was going to thrive and compete for growth like no other small rural town because of the people who live here. We are competitive and want to be successful in all areas, in our schools, in our down-town businesses and in our churches. We

keep our community clean and well organized with great leadership at the city and county levels as well as our Chamber, Parks and Rec, and our Economic Development. I have lived in a few small towns and Bowman feels prepared when opportunity presents itself.

Southwest Healthcare Services is a part of Bowman and Bowman County and reflects that desire to be competitive. We have a stateof-the-art facility and are now the largest, by bed capacity, Critical Access Hospital in North Dakota. The challenges we faced these past two years with COVID have been extremely trying on the staff at SWHC. We lost staff in key areas such as Nursing, Lab and Radiology to name a few. COVID burnout is a very real thing as we see across the country and healthcare, being at the tip of the sword, has seen a great deal of turnover. The Board of Directors, along with the providers and department heads, went

through a strategic planning process for 2022-2025 with a focus on these challenges. The five major organizational goals that fall under each of the following pillars

2022 will have a lot of the same challenges as we have seen in the recent years with COVID and the same challenge of retaining and recruiting staff. In this report I will outline the accomplishments of last year and a take a look at where we are seeing the greatest challenges and opportunities in the coming years.

SWHCS has had a very active year of recruitment. We had two providers join us in 2021 with Dr. Gard Adams and Dr. Roy Cordy both doing a great job for us. We saw Alli Engelhart, a long-term employee and Human Resource manager, leave us for another position outside of healthcare but were fortunate to have Mike Reddick join us as our new Human Resources Manager. We are also trying to replace a semi-retiring Clinical Laboratory Technician, Crystal Erickson. The Radiology department lost a technician, but we will be welcoming Caiden Goodman in July 2022 as a new employee and resident of Bowman. Respiratory Therapy hired a new Respiratory Therapist, Cheyenne Daniel, and she joined us in June 2022. We lost several CNAs, Housekeeping

and Dietary Staff but have been able to replace most of the positions in those areas. Mike Snow will be joining us as Facilities Manager In-Training in late June 2022.

SWHS had some successes in 2021. We had a positive bottom line in 2021 and due to a little help from the Cares Act we were able to cover the losses associated with COVID with subsidies. We also had improved operational efficiencies by consolidating our census into contiguous space rather than spread throughout the building. This allowed us to decrease staffing ratios as it reduced time to and from calllights.

Another area of operational improvement took place in Radiology. Unlike other facilities, we have been able to staff all our modalities, Ultrasound, Echocardiography, CT, DXA,

Mammography and MRI with a consistent schedule of qualified and certified technologists.

We sent Kathryn Yockim for ultrasound training in November of 2021 and is continuing that education with on-the-job training. Janel Bagley, the Radiology Manager, is trained in all modalities.

SWHS also was able to bring therapies back under our umbrella. Jen Jahner and Darren Criswell were with RehabVisions prior to December of 2021 when they decided to re-

rather than contracted staff. We added Erin Qualley to our Outpatient Nursing because of an increase in infusions taking place due to COVID and other reasons.

SWHS's biggest change in our operation was the change from a nursing home and a hospital to that of an expanded 35 bed Critical Access Hospital. This change in operations allows us to take care of our Long-Term Nursing Home patients in a lower cost set-

ting but with the exact same level of care. Frontier Community Health Integration Project (FCHIP) allowed us to expand our 25 bed Critical Access Hospital (CAH) to have 35 licensed beds. These additional beds will be used to care for nursing home residents, offering all the same services and in the majority of the same beds under

\$600,000 annually and also charge less for those that are at a higher level of care than we would have in the nursing home. In addition to moving into the CAH Expansion Program we are adding Basic Care services. Basic Care is not a Medicare covered service but is covered by Medicaid, private pay and long-term care insurance. A Basic Care facility is similar to a nursing home, but for seniors whose medical needs are not

as intense. North Dakota is the only state with basic care,

CAH reimbursement rather than nursing home reimburse-

ment methodology. By doing this, we will reduce our losses by

with 1,143 seniors currently residing in 65 basic care facilities that are supported by the state paying part of their room and board. We hope that this will help those residents in our service area that need help but are not currently eligible for nursing home care and cannot afford assisted living. We feel this is a critical need for our region. Amanda Loughman, our CFO, is in charge of Basic Care and will be presenting at the annual meeting.

With these and other changes in our operation

we feel we can strengthen our financial standing and improve both the quality of care and the services we are offering the community.

In closing, I want to thank all of you that are a part of the Southwest Healthcare family! The staff has stepped up on many occasions and I am very appreciative of all that they do for us. I also want to thank the Board of Trustees and all of the SWHS supporters for utilizing our services and supporting us in other ways such as the annual Celebrity Waiter Event and through the support of the city sales tax in Bowman. Without your support, the challenges would be even greater, so once again, thank you for your past, present, and future support!

2021 **Minutes**

20th Annual Meeting May 25, 2021 Bowman Lutheran Church

Julie Lockert, Board Chairman, called the meeting to order at 5:30 pm. A quorum of delegates was present. Pastor Chuck Johnson provided the opening reflection and prayer.

Julie Lockert welcomed everyone to the 20th Annual Meeting of Southwest Healthcare Services (SWHS). Minutes of the 19th Annual Meeting were presented and reviewed. Motion to approve the minutes was made by Benji Schaaf, seconded by Agnes Kitzan. Motion carried.

Annual Reports

Julie Lockert, Board Chairman, reviewed the Chairman's Report. 2020 was a challenging year for Southwest Healthcare Services, and we were grateful that Robert Letson was able to lead during the COVID epidemic. Sadly, Bob passed in November due to COVID.

Julie went on to thank the staff for all of their resiliency through this last year. She especially wanted to thank Amber Umbreit, CNO, and Amanda Loughman, CFO, for their leadership after Robert's passing. Julie also took the time to thank the community for all of their support.

Renee Gravalin presented the 2020 financials. In 2020, SWHS had operating revenue of \$14,805,661 with expenses totaling (\$15,652,010). This came to an operating loss of (\$846,349) with a net loss of (\$402,174). Southwest Healthcare Service also received Payment Protection Funds in 2020, but the loan was not forgiven until 2021.

Dennis Goebel, CEO, started by giving an introduction of himself and his experience. Dennis then shared his vision for Southwest Healthcare Services and his plan to keep SWHS viable in the future. In the first year, Dennis hopes to reduce SWHS expenses by \$900,000 by reducing staffing, consolidating the nursing home, reducing contact staffing, and recruiting permanent physicians. In 2022, SWHS also start

the FCHIP program that will allow us to receive cost reimbursement for the ambulance and enable us to expand our hospital beds to 35. With this, we will be converting our nursing home beds into long-term hospital beds.

The residents and families will see no difference in care, but it should reduce our bed prices while allowing us to keep more of the profit. We are also looking into converting some of our nursing home beds into basic care beds.

Ron Palczewski, Chairperson of the Sunrise Foundation, started with the exciting news that they have exceeded over 3,000,000 in assets! Ron then gave a brief history and synopsis of Sunrise Foundation. Giving Hearts is one of Sunrise Foundations' biggest fundraisers for the year, and in 2021, Barbie, Foundation Director, was able to raise over \$48,000. Thank you for all of your support.

At the end of the reports, community members asked questions about basic care and financial questions.

New Business

Election of Board Members:

Julie Lockert, Dan Powell, and Shonda Schwartz Second term is expiring.

Chuck Whitney nominated Laurie Braaten to serve a term, seconded by Dan Peterson. Motion carried. Benji Schaaf nominated Jordan Anderson to serve a term, seconded by Debbie Patterson. Motion carried. Julie Lockert made three calls for other nominations from the floor.

Deb Patterson nominated Wendy Stuber to serve a term, seconded by Retia Freitag. Motion carried. Pastor Renee Johnson provided a closing reflection and then led everyone in the Lord's Prayer.
